B. An Environmental Permit for the construction, operation and decommissioning of the HIW Energy Centre was enacted pursuant to section 8.06 of the Land Code as Land Law 2015/16-012 on 28 February 2016. The Environmental Permit includes the proposed mitigation described in the environmental assessment, or such alternate mitigation as Council deems appropriate to avoid or minimize adverse environmental effect or necessary to discharge its environmental stewardship responsibilities with respect to the Reserve lands affected by the HIW Wind Energy Centre.								
C. Council has determined that Land Law 2015/16-011, which deals with environmental protection in relation to the proposed HIW Wind Energy Centre, will provide adequate and effective measures to ensure compliance with the terms of the Environmental Permit at all material times during construction, operation, and decommissioning.								
D. Land law 2015/16-011 authorizes Arcadis Canada Inc. to act as Commissioner on an interim basis, with authority to appoint an interim Abatement Officer, and Arcadis Canada Inc. has accepted the interim appointment.
