INSTRUCTIONS FOR VOTER REGISTRATION

Henvey Inlet First Nation will be conducting a vote of the membership to ratify the Land Code and the Individual Agreement to be provided to you by the Lands Office. The vote has tentatively been set to take place at the Fire Hall on Pickerel River Road of Henvey Inlet First Nation on Thursday, November 26; Sunday, November 29; Monday, November 30; and Saturday December 5, 2009. The Notice of Vote is being prepared and is to be distributed by October 23, 2009.

As a member of Henvey Inlet First Nation, you are entitled to vote provided you will be at least 18 years of age on the date of the vote and have registered with the Ratification Officer. To assist you in the registering process, please find enclosed:

- A Registration Card
- An addressed and postage paid envelope

Carefully follow the steps below to ensure that you are registered in order to receive your ballot on the day of the vote or for prior if your intention is to mail-in your ballot.

- 1. Complete the form providing your full name and 10-digit band number in the required spaces. (If you do not know the 10-digit, use the 2, 3 or 4 digit number)**
- 2. Select one (1) only of the options listed on the registration card.**
- 3. Sign and date the form in the spaces required. (mandatory)**
- 4. Have a witness verify the information as correct and sign on the appropriate lines. (does not have to be a band member, but must be over 18 years of age)**
- 5. Place the complete Registration Card in the postage paid pre-addressed envelope.**
- 6. Seal the envelope and drop it in the mail as soon as possible.**

The Voter Registration Form may also be hand delivered to the Lands Office located upstairs in the Fire Hall of Henvey Inlet First Nation. The Ratification Officer will also accept registration forms that are faxed to (705) 741-2378, e-mailed to scott.jacobs@sympatico.ca or hand delivered at the polling or advance polling locations. The Ratification Officer must receive the registration form for your vote to be counted.

Please be aware that missing information or the failure to provide a witness signature will result in your exclusion from the vote until such time as your form is completed in full. Any Voter Registration Cards received after the close of the poll on December 5th, 2009 will not be accepted.

Once the Ratification Officer has received your Registration Card and following the posting of the Notice of Vote, a ballot package will be sent to your mailing address that you provided on the form if you have checked that you wish to receive a mail-in ballot. For those that will be able to attend one of the four voting dates, a ballot will be held for you at the polling station until you arrive.
